There are currently over 2,349 members of the RCN History of Nursing Forum, across the UK and from all areas of RCN membership including students, retired, full members, specialist nurses, activists, nurse associates and health care practitioners.

### About Us

The History of Nursing Forum is open to RCN members who want to learn more about their history and to promote awareness within the profession. We believe the history of nursing is wider than the study of nurse training and practice; it encompasses the experiences of individuals and groups, movements and organisations, religion and war, culture and gender, politics, and social ideas. It can include family history and local history where these touch on nursing.

The Forum regular activities include the co-creation of exhibition and events with other RCN Forums and the Library and Archive Service; creating oral history interviews; writing articles for Wikipedia, the RCN Bulletin, and other resources; supporting history of nursing forum groups in the regions; providing family history guides; and other activities. The RCN has led many developments in the history of nursing within the UK and at an international level. Our historic collections reflect this, with RCN Library and Archive Service (LAS) holding the largest nursing collection in Europe. Our oldest material dates from the 1600s though most of our printed and archival collections date from the 1870s with the rise of nursing schools. Focusing on English language materials the collections include the most comprehensive collection of nursing books, journals, PhD theses, pamphlets, rare books, grey literature, e-books, and e-journals as well as organisational and personal archives, audiovisual materials oral histories and objects. The collections hold material from across the UK and include

items belonging to iconic nursing leaders such as Florence Nightingale, RCN co-founder Sarah Swift and Trevor Clay.

The History of Nursing Forum reports to the Forums Governance Group (FGG); this positions the work of the forum within the decision making of the RCN and provides an opportunity to highlight the contribution that the history of nursing can make to contemporary nursing research, education, and practice. It promotes collaborative working across the forums.

The RCN Library and Archive Service Joint Head acts as Adviser to the forum which helps bring our members and our historic collections together, providing opportunities for collaborative projects in the network of history societies that flourish across the UK.

The forum works in partnership with external bodies and groups that lead on nursing history including:

- The <u>UK Association of History of Nursing</u> (UKAHN) a network for nursing historians, a number of whom are not eligible for RCN membership.
- The <u>European Association of History of Nursing</u> (EAHN), the American Association for the History of Nursing (AAHN), and other international networks for nursing historians who are not eligible for RCN membership.
- The <u>Florence Nightingale Museum</u> which leads on a number of nursing history projects.

#### **Monica Baly Award**

The RCN Foundation's Monica Baly Bursary Award is an annual award that gives financial assistance to undertake activities related to nursing history. These include undertaking courses, projects, research, and attending either a nursing history conference or study day to present a paper.

The RCN Foundation is responsible for the award. The History of Nursing Forum provides advisors to sit on the panel which reviews bursary applications and makes a recommendation to the Foundation as to each years' winner.

Please note the Monica Baly Bursary Award is open to UK-registered nurses or UK-based nursing students. The closing date for applications is usually in summer each year; check the website for details.

Monica Baly History of Nursing Grant to fund a research project up to the value of £1,000.

Applications are encouraged to focus on the history of any aspect of nursing and are particularly welcomed in the following areas:

- Gaps in historical research, for example, BAME nurses/midwives, nurses/midwives with disabilities
- Areas of practice where the history is not as well documented, for example: prison nursing, school nursing, mental health and learning disability nursing.

The Monica Baly Grant will be opening again in 2024, dates to be confirmed.

### **About Monica Baly**

The Monica Baly Fund was established through a gift from Dr Monica Baly's Will. Monica Baly entered nursing in the 1930s but always had a passion for history. On retirement, she combined these two interests to study the history of nursing. At the age of 70, she completed a PhD in Nursing and Social Change. Dr Baly's ongoing passion was reflected in her role as the first Chair of the RCN History of Nursing Society (our previous name).

Dr Baly established the Monica Baly Fund specifically to remove the stumbling block of lack of funds for registered nurses who might otherwise not be able to undertake history of nursing activities.
